

**Frito-Lay Sweet & Savory Twitter Party Giveaway  
OFFICIAL RULES**

**This Giveaway is intended for play in the 50 United States, the District of Columbia and Canada only and shall be construed and evaluated according to United States law. **HOW TO PARTICIPATE:** The Frito-Lay Get Sweet & Savory Twitter Party Giveaway (the "Giveaway") will begin on December 5, 2013 at 7:00 pm (CT) and end on December 5, 2013 at 8:00 pm (CT) (the "Giveaway Period"). The random drawing will be conducted by Susan Carraaretto (@5MinutesforMom) of 5 Minutes for Mom whose decision is final on all matters relating to the random drawing. Odds of winning a prize will depend upon the total number of eligible Entries received. All prizes will be awarded, provided a sufficient amount of eligible Entries are received, and prize winners will be notified via Twitter through a public Tweet and/or "direct message ("DM")", if applicable.
